Re: Issuance of Revised UC Academic Personnel Manual (APM) 700 Series - Leaves of Absence

Dear Colleagues:

Provost and Executive Vice President for Academic Affairs Michael Brown has formally issued the following revised leave-related policies of the 700 Series of the Academic Personnel Manual (APM):

- APM 700 Leaves of Absence/General;
- APM 710 Leaves of Absence/Sick Leave/Medical Leave;
- APM 715 Leaves of Absence/Family and Medical Leave;
- APM 720 Leaves of Absence/Holidays;
- APM 730 Leaves of Absence/Vacation;
- APM 740 Leaves of Absence/Sabbatical Leaves;
- APM 750 Leaves of Absence/Leave for Service to Governmental Agencies;
- APM 751 Leaves of Absence/Military Leave;
- APM 752 Leaves of Absence/Leave to Attend Professional Meeting or Other University Business;
- APM 758 Leaves of Absence/Other Leaves with Pay; and
- APM 760 Family Accommodations for Childbearing and Childrearing.

APM 759 Leaves of Absence/Other Leaves Without Pay is still under review. A revised policy will be issued at a later date.

There were substantive revisions to several policies which are outlined below.

Key policy revisions:

- APM 760 was updated to increase the existing paid childbearing leave from six weeks to eight weeks for academic appointees who do not accrue sick leave.
- A section on Pay for Family Care and Bonding (PFCB) was added to APM 715 and APM 760.

- APM 715 was updated to expand the definition of family members for whom an appointee may take a family and medical leave under CFRA to include grandparents, grandchildren, and siblings.
- APM 758 was updated to specifically address bereavement and jury duty leaves.
- APM 760 was updated to remove the age requirement for a newly placed child when determining eligibility for Active Service-Modified Duties (ASMD).

Conforming changes have been made in UCSC's Campus Academic Personnel Manual policy on Leaves of Absence (CAPM 900.700) to align with APM.
