The [Psychology Department](#) at the University of California, Santa Cruz (UCSC) invites applications for an ongoing pool of qualified temporary lecturers in Psychology. Outstanding candidates with experience to teach in any specialty within psychology (including introductory psychology, statistics, research methods, social, personality, developmental, clinical, cognitive/experimental, data analysis) are encouraged to apply.

Regular appointments are during the academic year, but accepted candidates will also be eligible for Summer Session appointments.

RANK: Lecturer

SALARY: Approximately \$6126 - \$8120 per course, commensurate with education and experience. Compensation for Summer Session courses may vary from this amount.

BASIC QUALIFICATIONS: Ph.D. or equivalent foreign degree in Psychology or related field.

POSITION AVAILABLE: As openings occur, appointments contingent upon availability of funding.

TO APPLY: Applications are accepted via the UCSC Academic Recruit online system, and must include a letter of application (including a list of courses qualified to teach); a curriculum vitae; sample course materials, if available; teaching evaluations, if available; and three confidential letters of recommendation from authorities in your field.* Documents/materials must be submitted as PDF files.
