On-Going Lecturer Pool in Writing

The [Writing Program](#) at the University of California, Santa Cruz, invites applications for an ongoing pool of qualified temporary instructors beginning with the fall quarter, to teach extra sections of (1) required first-year writing classes including those for students who have not satisfied the University of California's Entry Level Writing Requirement (ELWR); (2) courses with many students for whom English is a second language. Candidates accepted to our ongoing pool may be approached by other departments to teach in areas related to their demonstrated areas of expertise. The UC Santa Cruz campus is especially interested in candidates who can contribute to the diversity and excellence of the academic community through their teaching.

Please note: Applying to the ongoing Writing Program Lecturer Pool is a process separate from application to the ongoing College Writing Seminar Lecturer Pool, and requires a separate application.

RANK: Lecturer

SALARY: \$6,280 - \$6,763 per five-unit course, commensurate with qualifications and experience.

BASIC QUALIFICATIONS: Master's degree with experience in teaching English composition at the college level; formal training in Rhetoric & Composition or TESOL; experience working with a diverse student population. Knowledge of current theory and research in composition.

POSITION AVAILABLE: As openings occur, contingent upon availability of funding.

TO APPLY: Applicants should submit an informative letter of application describing their approaches to teaching writing and the connection of those approaches to research in Rhetoric & Composition and/or TESOL, as well as detailed information on their knowledge of current theory and research in composition; a curriculum vita (including an e-mail address); a diversity statement that demonstrates effectiveness at working with a diverse student population; three current letters of recommendation* dated within two years of the date of application; a syllabus for a course they think would be an appropriate introductory composition course for UC freshman; and the three most recent teaching evaluations for university level courses, if available. Documents/materials must be submitted as PDF files.
