



The [Education Department](#) at the University of California, Santa Cruz, invites applications for an on-going pool of qualified Supervisors of Teacher Education in English and/or Social Sciences. Responsibilities may include supervising student teachers in middle and high school classroom settings; teaching beginning, intermediate, and advanced student teaching seminars at the University; and serving on Education Department committees. Supervisors are also responsible for assisting credential candidates to complete a comprehensive assessment of their instruction based on the California Teaching Performance Expectations.

The Department prepares approximately 65 credential students per year for teaching in K-12 California public schools. The program, which also grants a Masters of Arts in Education, operates on a year-round schedule (summer to summer). The University of California, Santa Cruz, a Hispanic-serving institution (HSI), serves a mix of suburban and rural schools in which many students are immigrants or the children of immigrants. We are committed to inquiry-based pedagogies for preparing teachers to improve the education of linguistically and culturally diverse students and promote equity and social justice. Supervisors of Teacher Education normally hold full-time (100%) appointments during the academic year. In instances where selected candidates' appointments are less than full-time, they may apply to the Education Department's Lecturer pool if they would like to be considered for an additional appointment as Lecturer.

Applicants who are authorized bilingual teachers (BCLAD or equivalent) are encouraged to apply.

**PREFERRED QUALIFICATIONS:** M.A. in Education, or equivalent foreign degree, in a closely related field

**TO APPLY:** Applications are accepted via the UCSC Academic Recruit online system and must include the following materials: letter of application describing your K-12 professional experience, knowledge of local area districts, and experience working with adult learners; a curriculum vitae; a statement of your teaching philosophy; and confidential letters of recommendation\* (a minimum of two are required and a maximum of three will be accepted). Applicants may also submit copies of course syllabi (a maximum of the three will be accepted); course evaluations (a maximum of three will be accepted); and a copy of your BCLAD certification. Documents/materials must be submitted as PDF files.
